**ORDER**

The time limit for crediting arrears of DA to the PF Account of the employees allowed as per G.O. read 1<sup>st</sup> paper above, expired on 31.07.2009. The Time limit extended for crediting the DA arrears sanctioned with effect from 01.01.2006 as per Government Order read 2nd paper above has also been expired on 31.05.2009.

Several requests are being received from various Heads of Institutions and individuals seeking extension of time for crediting the arrears of DA to the PF Account.

Government have examined the requests and are pleased to order that the time limit for crediting the arrears of DA sanctioned from 01.01.2006, 01.07.2006, 01.01.2007, 01.07.2007, 01.01.2008 and 01.07.2008 to the PF Account of employees will be extended up to 31.12.2009. The DA arrears can be claimed in the salary bill up to December 2009 and credited to PF Account without fail.
