ORDER

The time limit for crediting arrears of DA to the PF Account of the employees allowed as per G.O. read 1st paper above, expired on 31.07.2009. Government have examined the requests and are pleased to order that the time limit for crediting the arrears of DA sanctioned from 01.01.2006, 01.07.2006, 01.01.2007, 01.07.2007, 01.01.2008 and 01.07.2008 to the PF Account of employees will be extended up to 31.12.2009. The DA arrears can be claimed in the salary bill up to December 2009 and credited to PF Account without fail.
