### **ORDER**

As per Government Order cited 1<sup>st</sup> above, the Government have revised the pay scales of State Government Employees and Teachers. Thereafter vide the Government Order cited 2<sup>nd</sup> above, orders were issued, revising the rates of daily wages in respect of different categories such as Clerk, Typist, Chain man, Security Guard, Class IV Employee, workers in Govt. Presses, Driver and Pump operator. By Government Order cited 3<sup>rd</sup> above, the 1<sup>st</sup> six scales of pay, ordered in the Government Order 1<sup>st</sup> cited, was modified. Under the circumstances, Government felt it necessary to enhance the rate of wages in respect of daily wage employees also.

2. Accordingly after considering the matter in detail, Government are pleased to revise the rates of daily wages in respect of the following categories as detailed below with effect from 01-08-2009.

Category	Existing Rate (Rs.)	Revised Rate (Rs.)
(i) Clerk	170	200
(ii) Typist	170	200
(iii) Chain man	150	180
(iv) Security Guard	170	200
(v) Class IV	150	180
(vi) Workers in Govt. Presses	150	180
(vii) Driver	170	200
(viii) Pump Operator	170	200

3. The rates as above will apply only for full-time work. This will not apply to those engaged casually for doing part-time work like sweeping.

4. The above rates will remain in force till the pay scales of State Government Employees are further revised. Any upward revision of Daily Wage rates over and above the above rates will be ordered only by Finance Department.


