Pay Revision 2004 – Revision of scale of pay - Classification of State Government Employees – Revised Orders issued.

ORDER

State Government employees are grouped in four classes viz. Class I, Class II, Class III and Class IV by the Pay Revision Commission based on the scales of pay assigned to the posts held by them. But Government of India have dispensed with the classification of their employees as class I, class II and class III etc. At present posts under Government of India are classified as Group A, Group B, Group C and Group D. The 8th Pay Revision Commission in their recommendations had suggested revised scales to the posts coming under the State scales of pay. The scale of pay recommended by the Commission in respect of first six scales have later been modified as per order issued in G.O. read as III above. At present there is no order specifying Classes/Groups among posts under Government of Kerala.

SC/ST Development Department had informed that classification of Government employees is required for settling issues related to issuance of Creamy Layer certificate.

Government have examined the case and are pleased to dispense with the existing classification as Class I, Class II etc, and State Government Employees holding regular posts, based on the revised scales of pay will be classified as Group A, Group B, Group C and Group D as shown below.
