Sub:- General Provident Fund – Sanction Orders for temporary withdrawals from General Provident Fund account - marking of copy to the Accountant General (A&E) – Instructions – issued.

Ref:- Lr. No. FMI/9-511/2009-10/118 dated, 04/08/09 of the Accountant General (A&E), Kerala, Thiruvananthapuram.

As per Government Decision No. 2 below the Ruling to Rule 16 of General Provident Fund (K) Rules one copy of the order sanctioning Temporary Advance from the General Provident Fund should be sent to the Accountant General (A&E) as and when they are accorded and another copy attached with the bills presented to the Treasury.

Since the General Provident Fund accounts of the subscribers are maintained by Accountant General, it is very important that the withdrawal details be let known to AG soon on sanction. This will enable the Accountant General to have proper account keeping, detect irregular withdrawals, if any, and identify missing debits.


