The scheme of Vocationalisation of Secondary Education was introduced in the state during the academic year 1983-84. The main objectives are to provide diversification of educational opportunities so as to enhance individual employability, reduce the mismatch between demand and supply of skilled manpower and to provide an alternative for those pursuing higher education. Government have recognized 21 VHSE courses on the recommendations of the State Council for Vocational Education and the advice tendered by the Kerala Public Service Commission as alternative/equivalent qualification for appointment to various posts in various Government departments. All the departments concerned had already been instructed to amend the respective Special Rules incorporating the VHSE qualifications for the selection to the posts having the equivalent or alternative qualification vide the G.O cited. Later the departments concerned are requested to expedite the amendment of respective Special Rules vide the circular read above. Meanwhile Government have received many petitions from the Vocational Higher Secondary Education passouts regarding the scope for the course. Government have examined the matter in detail and are pleased to order to constitute Secretaries Committee with the following members to discuss the matter and to amend the Special Rules of the concerned departments accordingly.
